THIS AMENDMENT is entered into effective on the date of the last signature between the city of Anderson (hereinafter referred to as Sub-recipient) and the Shasta Regional Transportation Agency (hereinafter referred to as SRTA).

The Sub-Recipient Cooperative Agreement (AGREEMENT) is being amended to allow an extension of the expiration date and to amend Appendix A to the AGREEMENT to outline FY 2018-19 Regional Surface Transportation Program (RSTP) Exchange Funds to Sub-recipient for performing RSTP Exchange eligible projects publicly nominated and approved by the SRTA Board of Directors:

WHEREAS, Section 1. Agreement with the Sub-Recipient and Amendments is amended as follows:

1. Agreement with the Sub-Recipient and Amendments

- a. This AGREEMENT between the Sub-recipient and SRTA and may be amended by written modification by both parties, for Fiscal Years (FYs) 2016-17, 2017-18 and 2018-19 RSTP Exchange Funds, and expires June 30, 2022, unless extended by mutual agreement between both parties.


WHEREAS, Appendix A is amended as follows:


